Several recent developments suggest that if an insured controls a corporation that owns an insurance policy on his life, he may be required to include the policy proceeds in his gross estate upon his death. ### Evaluating a Developing Institution: Mexicanization of Mining

An analysis of the institutional forces acting on Mexican mining policy. The writer examines socioeconomic demands that led to Mexicanization, appraises the political process that perceived and implemented it, and evaluates the effects of the law on the Mexican mining industry. He also suggests an overall approach to be used in analyzing the effectiveness of developing legal institutions.

### Protection for Employees Adversely Affected by Railway Mergers:

Norfolk & Western Railway Co. v. Nemitz .....*James F. Morrow* 703

Railroad mergers produce special problems for the industry's workers who may be adversely affected. The writer analyzes the conflict between the Railway Labor Act and the Interstate Commerce Act, as recently interpreted by the Supreme Court.

### Streenz v. Streenz: The End of an Era of Parental Tort Immunity

*Michael L. Winchester* 720

The doctrine of parental tort immunity has met increasing judicial disfavor in recent years, resulting in many exceptions to the general rule and either partial or total abrogation. The writer examines the doctrine's historical background, its justifications, the policy reasons behind its demise, and the possible impact of abrogation. A reasonable-parent test is proposed as the ultimate solution to such cases.
